CREDIT AGREEMENT

This credit application and agreement is submitted to Vegas Materials, Inc. (hereafter referred to as VMI), to obtain business trade credit. Customer agrees to make payment in full to VMI for all amounts due according to the terms of VMI's invoices. Customer also agrees to pay VMI interest on all past due amounts at the rate of 1 ½% per month or the maximum allowed by law. A \$15.00 charge will also be assessed for any returned checks.

Should Customer fail to make any such payment when due, VMI shall have the right, without notice to Customer, to declare all outstanding invoice amounts immediately due and payable. In the event that VMI commences any legal action, or otherwise seeks to enforce this agreement against Customer, Customer agrees to pay all actual attorney(s) fees, court cost and all other collection expenses incurred by VMI, whether or not suit is filed, including, but not limited to, a collection fee equal to THIRTY PERCENT (30%) of the principal and interest due on all invoices assigned to a collection agency for collection.

Customer agrees that any change in its form of business organization (i.e. from a sole proprietorship to a corporation) shall not alter the liability of the undersigned to VMI for any obligation incurred by the undersigned prior to the time that VMI receives actual notice of such change by certified mail. This credit application and agreement is entered in and shall be governed by and construed in accordance with the law of the State of Nevada, County of Clark shall have exclusive jurisdiction to hear and determine any claims or disputes between VMI and Customer pertaining to this credit application and agreement. Customer waives any right it may have to assert the doctrine of forum non convenience (i.e. inconvenient forum) or otherwise object to such venue. Customer expressly submits and consents in advance to such jurisdiction in any action or proceeding commenced in such courts.

This credit application and agreement may be executed by the Customer by original or facsimile signature, and any such facsimile signature shall have the same effect as the original signature of the Customer.

Each person signing this credit application and agreement on behalf of any entity for which he or she purports to act, represents and warrants to VMI that he or she is duly authorized to execute this credit application and agreement on behalf of such entity by virtue of a duly enacted corporate or partnership resolution, as the case may be. The undersigned Customer authorizes the release of its credit and banking information to VMI by the references listed above for the purpose of establishing business trade credit with VMI.
